Appellate Court Finds That Insureds Are Members Of The Same Household When They Live Together

Nicotera v. Allstate Ins. Co., N.Y.S.3d, 2017 WL 538229 (4th Dep't Feb. 10, 2017).

The New York State Appellate Division, Fourth Department recently examined whether relatives were considered members of the named insured's "household." See Nicotera v. Allstate Ins. Co., -- N.Y.S.3d --. 2017 WL 538229 (4th Dep't Feb. 10, 2017). Nicotera involved fire damage to a two family home in Utica, New York. The home originally was owned by Virginia Eannace; however, in 2003, she transferred the home to an irrevocable family trust. Mrs. Eannace named her two nieces, Gioia L. Nicotera and Marisa L. Nicotera, as beneficiaries of the trust. The home was insured by a homeowners' policy with Allstate Insurance Company. Despite the transfer of the home to the trust, Mrs. Eannace remained the only named insured on the policy.

In 2010, Mrs. Eannace moved out of the home and into a nursing home. Shortly thereafter, Mrs. Eannace's niece, Gioia, occupied the first floor of the home and two tenants occupied the second floor. In 2012, the home was damaged by a fire. Allstate disclaimed coverage based on the fact that its insured, Mrs. Eannace, did not reside at the insured property at the time of the fire. The trustees and beneficiaries of the trust (the "plaintiffs") commenced a lawsuit against Allstate for breach of contract following its denial of coverage. Allstate moved for summary judgment contending that the named insured did not reside at the home; therefore, there was no coverage. Instead of challenging Allstate's basis for its denial, the plaintiffs contended that there was coverage because Gioia was an insured under the policy who resided at the home. They argued that she was an insured because she was a member of Mrs. Eannace's household and a relative. Under the policy at issue, an insured person included any member of Mrs. Eannace's household if such a person was a relative. The trial court granted Allstate's summary judgment motion and dismissed the plaintiffs' complaint. The plaintiffs appealed.

Initially, the Fourth Department noted that "household" has been characterized as an ambiguous term; thus, any interpretation must favor coverage and reflect the "reasonable expectation and purpose of the ordinary business person when making an insurance contract and the meaning which would be given it by the average person." Certainly, there was no dispute whether Gioia was a relative. There also was no question whether Gioia resided at the insured property. Given these facts, if Gioia was a member of the household, there would be coverage because she would be an insured under the policy. However, the Court held that Gioia was not a member of Mrs. Eannace's household and concluded that it could not interpret the policy to provide coverage where the named insured and the relative did not live in the same "household." Simply put, Mrs. Eannace and Gioia were not members of the same household because they did not live together in the home, so the Court affirmed the trial court's dismissal of plaintiffs' complaint because for relatives to be members of the same household, they must live together.

Practice Pointer: The holding in the Nicotera case provides an illustration of how important it is for insurance agents to communicate with insureds (and potential insureds) to secure accurate information about the use and occupancy of insured properties. For example, in Nicotera, if the plaintiffs had updated the homeowners' policy when Mrs. Eannace moved out and Gioia moved in, they could have added Gioia to the policy and their likely would have been coverage for the loss (assuming no other defenses to coverage applied). Insurance agents may best serve their client and protect themselves from liability by communicating regularly with their insureds to ensure that they have the most up-to-date information on the use and occupancy of an insured property. The simple use as a yearly or bi-annual property update form sent to your clients may make the difference between ensuring that your clients have proper coverage, and protecting your agency from an errors and omissions claim.



IIABNY members whose E&O coverage is written by Fireman's Fund on the IIABA RPG ProGuard Form may qualify for a 10% premium reduction on their 2018 renewal if the required agency staff (see left) attend a designated E&O seminar in the 2016 calendar year. IIABNY members whose E&O coverage is written on the non RPG Form may qualify for a 7.5% premium reduction on their 2018 renewal if they follow the attendance guidelines.

The above are minimum requirements. You are encouraged to send as many of your office staff as is practicable.

Please note – These requirements must be met on an annual basis. Attending previous E&O seminars will not qualify an agency for the 2018 premium reduction.

IMPORTANT NOTICES

- You must register at least two weeks prior to the seminar to receive your CE certificate on site.
- Continuing Education rules will not allow CE credit to be awarded to anyone arriving after the start of the program.
- Full payment must be received prior to admittance.
- Photo ID must be presented at registration.
