PROJECT INVEST SCHOLARSHIPS

Each year IIAAWNY offers scholarships to students who have participated in the Project Invest program through their school's Academy of Finance. This year we offered 10 scholarships in the following amounts: (2)-\$1,000, (4)-\$500, (4)-\$250. We presented the program in three school districts this year, had 12 scholarship applicants and presented winners from each school. I would like to highlight our two top scholarship award winners, both from Hamburg High School!

Dana Bender will attend Cleveland State University in the fall and plans to study Business Economics and hopes to find a future career in Financial Analysis. She has been active in several sports, extra-curricular activities, and volunteer efforts throughout high school. Dana has earned many scholastic and achievement awards as well. LEGAL INSIDER

The Fourth Department Takes Issue With Insurance Policy Contractual Limitations Period

Lobello v. New York Cent. Mut. Fire Ins. Co., 2017 N.Y. Slip Op. 05543 (4th Dep't July 7, 2017)

Recently, the Appellate Division, Fourth Department created new precedent when it overruled its previous decisions and held that the deadline to commence a lawsuit against an insurer begins to run from the date of the alleged breach of contract and not the date of the incident giving rise to the claim. See *Lobello v. New York Cent. Mut. Fire Ins. Co.*, 2017 N.Y. Slip Op. 05543 (4th Dep't July 7, 2017).

In Lobello, the plaintiff-insured suffered losses in 2009 and 2010. Shortly after the two-year anniversary of the 2009 loss, NYCM denied coverage for both losses. Thereafter, the plaintiff commenced a lawsuit against NYCM for breach of contract. Following discovery, the trial court dismissed the plaintiff's complaint in connection with the 2009 loss, because the insurance policy provided no lawsuit could be brought against NYCM unless it was "started within two years after the date of loss"; however, the plaintiff's lawsuit was commenced more than two years after the 2009 loss occurred. In support of its decision, the trial court relied on two decisions by the Fourth Department that applied similar policy language to dismiss several lawsuits. See Baluk v. New York Cent. Mut. Fire Ins. Co., 114 A.D.3d 1151 (4th Dep't 2014) and Klawiter v. CGU/OneBeacon Ins. Grp., 27 A.D.3d 1155 (4th Dep't 2006).

On appeal, however, the Fourth Department reversed the trial court's decision, and it expressly disavowed its previous decisions in *Baluk* and *Klawiter* as no longer being good law. The Fourth Department noted the phrase "date of loss" was undefined in the policy, and it also noted there was Court of Appeals precedent from 1966 stating "inception of loss" was the proper phrase to describe the date when a loss actually occurred. *See Proc v. Home Ins. Co.*, 17 N.Y.2d 239 (1966). Accordingly, the Fourth Department held "date

of loss" was ambiguous and had to be construed in the insured's favor to refer to the date when "the loss became due and payable." Said another way, the Fourth Department determined "date of loss" referred to the date NYCM denied coverage (i.e, the date of the alleged breach of contract), and not the date on which the incident giving rise to the claim occurred.

Practice Pointer: Policy forms across New York State regularly provide that lawsuits against an insurer must be commenced within two years of the "date of loss." In light of the Lobello decision, however, the two-year limitation to bring a lawsuit against an insurer will not toll from the date of the incident that occurred. Rather, the suit limitations period will toll two years from the date of the denial or the alleged breach occurred. We suspect that many insurers will begin the process of revising relevant policy forms to change the suit limitation language to ensure that lawsuits are commenced within two years from the "inception of loss." If the policy forms are not updated, then the time period for an insured to commence a lawsuit will not begin to run until an insurer denies coverage or issues an undisputed payment. Under the current case law, insureds will have significantly more time to weigh their options and to seek out plaintiffs' attorneys to take their cases after an insurer denies coverage for a claim. Consequently, we expect that claims will remain open and unresolved for longer periods of time and litigation expenses likely will increase, because more lawsuits may be filed against insurers, agents, and brokers.






